

# Legislative Update – April 7, 2017

## Highlights of the Week:

The Missouri Senate worked all week on SS SB 41, the bill to ban sanctuary cities for abortion. The companion bill to SS SB 41 is HCS HB 174. The Senate also debated SS SB 67, the bill requiring annual inspections of abortion facilities and accountability of baby body parts from abortion.

The Missouri House worked to pass all budget bills. Budget bills now move to the Senate.

Regarding the Ban of Sanctuary Cities for Abortion bills:

Whether HCS HB 174 or SS SB 41 passes, this is necessary because an ordinance (BB 203 - “with an emergency clause”) was passed by the Board of Aldermen in the City of St. Louis interfering with the religious liberty of alternatives-to-abortion agencies and other religious affiliated organizations and their agents to freely engage in religious practices and speech that does not include abortion.

In these bills, a political subdivision of this state is preempted from enacting, adopting, or enforcing any ordinance or any other form of regulation that would interfere with, or otherwise adversely affect religious liberty.

It is necessary to enact this language immediately because BB 203 will force alternative-to-abortion agencies, churches and others to be complicit in the profound evil of abortion.

**Without HCS HB 174 or SS SB 41 this could happen in any city in Missouri!  
Governor Greitens has committed to signing this pro-life legislation!**

1. Alternatives-to-Abortion funding
2. Show-Me Healthy Babies Funding
3. Continued defunding of Planned Parenthood from receiving tax dollars through our state budget
4. Women’s healthcare without offering abortion services
5. Funding for transportation of umbilical cords to Cord Blood Bank
6. Pro-Life protective language in Economic Development Budget bill on research line item to prevent public funding of human cloning, embryonic stem cell research and abortion services
