

Legislative Update: May 3, 2014

Spotlight for the Week:

SCS HB 1132 and SCS SB's 638 & 647: Representative Kevin Engler and Representative Jeanie Riddle, Sponsors of the House bill and Senator Gary Romine, Sponsor of the Senate bill – These omnibus benevolent tax credit bills include increasing the amount of tax credits for contributions to pregnancy resource centers and maternity homes available in each fiscal year from \$2 million to \$2.5 million dollars. These bills garnered strong bi-partisan support.

SCS HB 1132:

Third Read and Passed the House by a vote of 113 yes and 36 no, March 13. SCS HB 1132 Third Read and Passed out of the Senate by a vote of 30 yes and 1 no, April 30. Sent back to the House for final vote.

SCS SB's 638 & 647:

SCS SB's 638 & 647 Third Read and Passed the Senate by a vote of 28 yes and 2 no, April 23. SCS SB's 638 & 647 Voted Do Pass out of House Rules Committee.

HCS HB 1478 & SB 770 will place in statute stricter inspection requirements and more accountability for abortion clinics. It will establish statutory requirements rather than relying solely on regulations for oversight of abortion clinics and will be less subject to the agenda of a particular agency or political party.

Atrocities at abortion clinics in Pennsylvania and Texas and many violations of health requirements at the St. Louis Planned Parenthood facility where there have been multiple 911 calls over the last 4 years illustrate the need for this legislation.

We thank Senator Wayne Wallingford, Sponsor of SCS SB 770 and Representative Kathryn Swan, Sponsor of HCS HB 1478 and all the co-sponsors for working to move this important life-saving legislation forward and help get it to the Governor's desk. HCS HB 1478 has over 100 co-sponsors.

GOOD NEWS ON ECONOMIC DEVELOPMENT BILLS:

PRO-LIFE PROTECTIVE LANGUAGE HAS BEEN PLACED ON THE FOLLOWING FIVE ECONOMIC DEVELOPMENT BILLS AS OF MARCH 5.

HCS HB 1310 & 1236: Representative Noel Torpey and Denny Hoskins, Sponsors – Establishes the Missouri Angel Investment Incentive Act – Opens the door for public funding of human cloning and embryonic stem cell research
January 22, MRL told by vice-chairman (acting chairman at the time), during committee testimony, that testimony was only being taken for HB 1310 and not on HB 1236 – even though both sponsors for HB 1236 and HB 1310 both presented their bills together and everyone giving testimony in support of these bills, including MOBIO, the lead group seeking public monies for human cloning and embryonic stem cell research, gave testimony for both bills. MRL turned in testimony in opposition to both HB 1310 and HB 1236. HB 1236 never had a separate presentation in the hearing. It was on the hearing list, shows that a hearing was held but there was no separate time in the hearing to give testimony on HB 1236.

Budget Bills

Budget Bills have been Third Read and Passed out of the Senate, the House and Senate have Refused to Accept the other's version. The budget bills will move to Conference Committees next week to address the differences in the House and Senate Versions. Budget bills must be truly agreed and finally passed by the end of the day on May 9, 2014.

Missouri Right to Life has worked to continue funding for the Alternatives to Abortion Program. This important program provides funding for pregnancy resource centers and maternity homes. These programs help women in crisis pregnancies through difficult situations and will help them choose life for their unborn babies.

Missouri Right to Life also continues to support pro-life protections on the Department of Economic Development Budget Bill to ensure that public monies are not used to fund or subsidize human cloning or embryonic stem cell research.
