Being Pro-Life is Not Just About Abortion

The following letter was recently sent to all Missouri pro-life legislators by Missouri Right to Life.

a better understanding of human DNA, and with the added threat of health care rationing, the need for protection of innocent human beings has expanded beyond what any of us thought we would see in our lifetimes. While many may still be singularly focused on abortion, it is not the only issue on which to base ones pro-life credentials.

Missouri Right to Life is concerned with all threats to innocent human life from the very beginning forward. It is erroneous and misleading when one portrays oneself as pro-life without a willingness to protect all innocent human life at every stage of development

As pro-life legislators, your consistency on all life issues is critically important to advancing the cause of life in Missouri. This means not only working to protect the lives of unborn children, to protect and inform mothers in crisis pregnancies, and to support alternatives to abortion programs. Being pro-life also means preventing euthanasia, infanticide, rationing of health care, and working to prevent human cloning and research that destroys human life.

Since the 2006 passage of Amendment 2 creating a constitutional right to

clone and kill human embryos in Missouri, the biotech industry has sought to fund this life-destroying research by accessing taxpayer money under various economic development schemes like the 2011 Missouri Science Innovation and Reinvestment Act (MOSIRA). Missouri Right to Life has consistently sought language in any such legislation that would provide pro-life protections.

While those who oppose our efforts claim we are anti-research, nothing could be further from the truth. We support

research on human stem cells as long as those cells are not derived by destroying human embryos. We enthusiastically support research using adult stem cells or induced pluripotent stem cells. All successful research using stem cells has been as a result of using these non-embryonic sources.

Even the 2012 winner of the Nobel Prize for Physiology and Medicine, Dr. Shinya Yamanaka, agrees with our position. When he saw that embryonic stem cell research destroyed a human embryo, he realized that embryo could have been one of his daughters. As a scientist involved in stem cell research, Dr. Yamanaka was so concerned about research which destroyed human embryos that he sought another avenue for developing stem cells with the same degree of pluripotency. His efforts to find ethical alternatives led to his discovery of induced pluripotent stem cells, a method of stem cell development that creates pluripotent stem cells from adult stem cells with no destruction of human life. For this he received the Nobel Prize.

Yet the biotech industry and those who do their bidding refuse to abandon their commitment to unrestricted research regardless of the potential destruction of countless human lives and zero success from unethical sources. You will be pressured by lobbyists from

this industry and members of your own caucus unwilling to accept this truth to support their anti-life agenda.

We are very blessed to have solid majorities in both houses of legislators that oppose abortion. These legislators have passed excellent legislation in past sessions regarding abortion, and we will work for additional anti-abortion legislation this year. However, abortion is not the only pro-life issue. We urge you to be strong and to stand up for life on all issues.

Acceptance of euthanasia heightens patients' distrust of medical profession

Martin Cullen, an intensive care physician in Sydney (Australia),

writes that the increasing acceptance of euthanasia has helped increase patients' distrust of doctors.

"I never cease to marvel how deeply some families of my patients distrust the medical profession," says Dr. Cullen. "Between me and them is a wall of suspicion. I know how used car salesmen must feel."

"No longer do families assume that their loved one will be cared for," he continued. "Families feel they need to be advocates for their sick relative. They aggressively question all of my suggestions for care. I really can't blame them. In the Netherlands, where euthanasia has been legalized, non-voluntary euthanasia, aka murder, is no longer unknown."

"Nowadays when I bring bad news to families and tell them that death is imminent and that we can do no more, I expect resistance and hostility," he added. "Just a few weeks ago I was treating an elderly woman who was very sick. Her family told me that they believed that their father had been euthanized years before. They weren't going to let us doctors take their mother, too. They looked at me as if I were a murderer. It was very unsettling for me."

Nevada Judge Refuses to Order Abortion for Mentally Challenged Woman

On November 14, a Nevada judge ruled against forcing a 32-year-old woman to have an abortion.

The woman, who has the mental capacity of a 6-year-old, became pregnant about 13 weeks ago after she wandered away from the Reno group home where she lives. According to Fox News, her family doesn't know whether she was raped or had consensual sex; the father has not been identified.

The woman and her parents, who are Catholic, chose to have the baby -- but after learning of the pregnancy in October, Washoe County Social Services asked the court to intervene in an effort to override their decision, saying a status hearing was necessary to discuss the potential effects the woman's pregnancy could have on both her and her preborn baby. The case went all the way to the Nevada Supreme Court before being kicked back to a lower court for a decision.

Jason Guinasso, a local attorney with the Alliance Defending Freedom (ADF), who represented the family, said that because the woman's parents are her legal guardians, the court has no right to intervene in her health issues -- including pregnancy.

Washoe County Family Court Judge Egan Walker said he plans to hold more hearings in the upcoming weeks to determine the safest way to move forward, but refused to order the woman to have an abortion. Though the woman's parents said the pregnancy could carry potential risks to their daughter and the baby, medical experts support their decision to continue the pregnancy.

"We are pleased (the pregnant woman) will be able to carry her baby to term and that the court recognized that childbirth is a natural process and is the generally accepted course of treatment for pregnancy," said Nevada Right to Life President Melissa Clement.

Catholic Bishops: We Will Not Obey Immoral HHS-Abortion Mandate

Video has surfaced of Cardinal Timothy Dolan, president of the U. S. Conference of Catholic Bishops, who said the Catholic Church will not obey the pro-abortion HHS mandate the Obama administration put forward.

"The only thing we're certainly prepared to do is not give in -- not violate our consciences and not obey what we consider to be something immoral," Dolan said November 13, as LifeNews reported. "That we're committed on."

"We took a bit of a breather as we waited for election day because the results of election day could have changed the playing field. It didn't. So now I think the bishops have taken a deep breath and said we better get back to work and decide just what we are going to do," he said. Saying he remains open to the Obama administration working out an acceptable compromise, he added, "I would say no door is closed, except the door to capitulation."

On the prospects of closing Catholic hospitals if the Obama administration won't relent, he said, "How we do that and what doors would remain open to us to see if there's some way consonant with our high moral principles to be able to do it, that's something we've got to start to tackle -- and we're prepared to tackle."

Missouri's pro-life representation in the U. S. House of Representatives remains strong with six of eight seats held by proven pro-life representatives.

While the election kept one of the Missouri's U. S. Senate seats in antilife hands, we are thankful that Sen. Roy Blunt is in Washington to speak for pro-life concerns.

Both houses of Missouri's General Assembly remain strongly pro-life with veto-proof majorities.

No endorsed candidates were elected to statewide office.

In a year that was disappointing in some important elections, Missouri Right to Life PAC candidates nonetheless won in 63% of their races.
