Pain-Capable Unborn Child Protection Act sidetracked by a few renegade House members

The 42nd anniversary of the Roe v. Wade decision was a day of mixed emotions, a great high and a deep disappointment.

Marches, rallies, and memorial services were held across the nation to remember the 57 million unborn children who have been lost to abortion, along with prayers, thoughts, and concern for the mothers of those children. In the nation's capital, the numbers were surely in the hundreds of thousands.

January 22nd was a day of joy as we celebrated the gift of *Life*. We rejoice as we see so many young people getting involved and taking a stand for life; saying they will be a voice for the voiceless; and promising they will not let this battle end.

It was also the day we were expecting the U.S. House of Representatives to pass the Pain-Capable Unborn Child Protection Act. Unfortunately, a small number of members of the House reneged on previous commitments and launched a campaign that sidetracked the bill, for now.

The No Taxpayer Funding for Abortion Act was a major priority for NRLC. We are pleased the House passed that bill.

Congresswoman hopes House leadership will listen to her ... not the voters

If you watch House proceedings on C-SPAN, you may not notice that members use electronic voting cards to cast their votes for or against a measure. In a National Journal article about the "dispute" over the Pain-Capable Unborn Child Protection Act, a reporter related this quote from an unnamed congresswoman who had helped sidetrack the bill: "I think the leadership genuinely feels bad about this... I hope that that will translate into listening to people who have voting cards instead of listening to people who don't have voting cards."

This congresswoman hopes that House leadership will listen to her and other members of Congress, not the voters who put them all there.

One of the most famous speeches in American history was President Lincoln's Gettysburg address. Lincoln memorably concluded that our government was "of the people, by the people, for the people." I wish I knew who this congresswoman was so I could send her a copy of the speech.

Another surprising aspect was the claim by Rep. Renee Ellmers (R-NC) – who gave numerous media interviews attacking the bill -- that passing the Pain-Capable Unborn Child Protection Act could hurt the Republican Party with millennials (i.e., persons age 18 to 29 or so) – a claim that some journalists apparently found plausible and amplified.

Quinnipiac University Poll on abortions after 20 weeks

Yet a November 2014 Quinnipiac University Poll asked:

"As you may know, in 2013 the House of Representatives approved legislation that would ban virtually all abortions nationwide after 20 weeks of pregnancy, except in cases of rape and incest that are reported to authorities. Would you support or oppose such legislation?"

Sixty percent of all respondents supported the legislation, compared to 33% opposed. Among those ages 18-29, there was 57% support for the legislation, with 38% opposed. In what other poll would a 19% advantage be considered a disadvantage?

This incident reminds us that politics is a messy business. But it's also a necessary one if we are going to protect unborn babies. We remember what happened, we hold elected officials accountable, and we keep on keeping on.

I urge you to contact your representative in Congress -- let them know you are disappointed in what happened and ask that they vote to pass the Pain-Capable Unborn Child Protection Act.

Planned Parenthood President: "We proudly provide ... abortion" that killed 327,653 babies in 2013

More than half a million prolife people took to the streets of Washington D.C. to solemnly mark

42 years of legalized abortion since the infamous Roe v. Wade decision. But one top abortion activist celebrated the occasion.

As CNS News reports, "at an invitation-only press conference ... at the National Press Club, Planned Parenthood President Cecile Richards told hand-picked reporters that her organization takes pride in the millions of abortions done at its affiliated clinics around the United States"

As it reports, Richards said: "We proudly provide safe and legal abortion."

The abortion giant Planned Parenthood recently released its 2013 annual report and the new numbers indicate it did more abortions than the previous year. The

report indicates Planned Parenthood did 327,653 abortions in 2013, an increase over the 327,166 abortions it did in 2012.

Some other takeaways from Planned Parenthood's own figures:

- In 2013, abortions made up 94% of Planned Parenthood's pregnancy services.
- For every adoption referral, Planned Parenthood performed 174 abortions.
- Planned Parenthood's cancer prevention services are down 17% over one year, and contraceptive services dropped by 4%.
- During fiscal year 2013-2014, Planned Parenthood received more than \$528 million in taxpayer funding, or more than \$1.4 million per day, in the form of government grants, contracts, and Medicaid reimbursements.
- Taxpayer funding accounts for 41% of Planned Parenthood's overall revenue.
- Planned Parenthood reported more than \$127 million in excess revenue, and more than \$1.4 billion in net assets.

he question I had to ask myself, **L** as I stared at that invoice was the question that got me involved in the prolife movement."

As I listened to this pregnancy center worker's story, my heart dropped as I was asking myself the same question. It wasn't an easy question to think about. But it was one that gave me a gut check regarding why we are all in the pro-life movement.

January means resolutions and cold weather. Both of those tie in perfectly to a date that breaks our hearts but strengthens our resolve - the anniversary of the Roe v. Wade decision on January 22.

The day that marks legal abortion being imposed by judges is the saddest day on the American calendar. Yet this anniversary brings out the best in people, as hundreds of thousands -- courageously led by

those who have had abortions -- march, pray, and endure the cold to give a voice to the 57 million babies who have lost their lives to abortion in the United States since 1973.

The week of the Roe anniversary is always my busiest week of the year. Leading up to it, I think about why I first got involved in the pro-life movement, back when I first attended Roe anniversary events in high school.

Abortion will end if we persevere persevere in prayer, persevere in resolve, and persevere in reminding ourselves of the great evil that abortion is. This isn't always easy, but it is needed. When we encounter setbacks or defeats throughout the year, we cannot forget what and who is at stake. An unexpected encounter reminded me of what we are fighting for and why so many march in the cold this time of year.

I spoke at a pregnancy center dinner and afterwards was visiting with attendees. As it got late, the room emptied out -- and one of the center's staff members came up

She had worked at a very large Planned Parenthood abortion facility near a major city. She justified her job because she did bookkeeping and other business tasks that were separated (she thought) from what went on in the rooms next door where the abortions were done.

She relayed this information to me very comfortably and then said, "But that

I was sitting at my desk." She then, in a troubled tone, said that she opened and read an invoice. "The invoice was to Planned Parenthood from the local morgue. It was for \$350." As she scanned the invoice to see what it was for, the reality of abortion hit her.

She continued, "The service listed was in bold letters that pierced my heart: Cremation Service for 150 Pounds of Medical Waste."

My heart sank.

She looked me in the eye and said, "Shawn, the question I had to ask myself as I stared at that invoice was what first got me involved in the pro-life movement. The question that pierced my heart was: How many babies have to be aborted to add up to 150 pounds of ash?"

I didn't know the answer. And a big part of me didn't want to know the answer.

She went on to tell me how she resigned from the abortion industry and began working for a local pregnancy center to help women in need and to welcome

babies into the world.

I travel a lot and hear a lot of stories from salt-of-the-earth people that are working to end abortion; but that night I couldn't sleep. I kept thinking about that question and it tied back to the basic reason we pray, march and persevere -- because abortion kills a baby.

It's something we all know; and when I first realized it at a Roe anniversary event as a teenager, I was convicted to do something about it. We all know abortion kills a baby -- but we can never become numb to it. Occasionally, we are reminded of how gruesome this reality is.

Thank God we are not paralyzed in our conviction - we can do something about it but it takes courage. C. S. Lewis said it best: "Courage is not simply one of the virtues, but the form of every vir-

tue at the testing point."

After 42 years of legalized abortion, we are at that testing point. For many, the Roe v. Wade anniversary is an opportunity like no other during the year to make resolutions to commit (or re-commit) ourselves to the love, joy, and courage required to see abortion end in our nation.

It may include being cold or enduring an awkward moment when you invite friends who have never participated before, but the anniversary that causes us to mourn also serves as the joyful rallying point to trust God that one day soon Roe v. Wade will be a dark memory of American history. Let's take advantage of every Roe anniversary, while working to make it the last one by committing to prayer and action.



U.S. Supreme Court to hear Obamacare challenge

Next month, the U.S. Supreme Court will hear argument in what could be the biggest challenge to Obamacare yet. The case is called King v. Burwell.

I filed a friend-of-the-court brief on behalf of Missouri citizens, and this is the bottom-line: if the challenge succeeds, this case could effectively end Obamacare in 34 states. Including Missouri.

The suit is all about whether the Obama Administration can spend federal subsidies in states, like Missouri, that have voted not to set up Obamacare exchanges. At the time of

the Affordable Care Act's (ACA) adoption, even Democratic supporters worried that the law might effectively nationalize healthcare in the United States. To address this (very justified) concern, the ACA's supporters wrote the law to provide for state-run healthcare exchanges. The ACA invited states to set up and manage these exchanges where insurance would be bought and sold; for states that cooperated, the law made available generous federal subsidies for use on the exchanges.

But here is the thing: thirty-four states decided not to set up an exchange. That includes Missouri. In 2012, the voters of Missouri overwhelmingly said "no" to establishing a state exchange. According to the text of the ACA, that means the federal government may not spend federal insurance subsidies in Missouri.

And this is the most important part. The ACA further provides that if federal subsidies are not available in a given state, the individual mandate and the mandate on business does not apply.

That means, according to President Obama's own law, no Missouri citizen should be forced to purchase Obamacare health insurance. And it means that no Missouri business should be forced to provide Obamacare-approved insurance to its employees.

Now the administration is trying to evade its own law by issuing rules that essentially ignore the decisions of Missouri voters and millions of Americans in thirty-three other states.

On behalf of the thousands of Missouri voters who elected not to set up an Obamacare exchange, Missouri Liberty Project has filed a brief before the Supreme Court urging the justices to honor the democratic decision of the people of Missouri and to enforce the ACA as it is written. No president should be able to change the letter of the law with a stroke of a pen. And every president should be required to obey the Constitution and the separation of powers.

President Obama forced his healthcare law on the American people. It's time to make him obey it.
