Bills to Watch:

Below you will find a list of legislation for the 2022 legislative session. At this time there have been 613 bills and 61 various resolutions filed in the Senate. And, there have been 1486 bills and 132 various resolutions filed in the House.

Anti-SLAPP would help to curtail frivolous lawsuits against people expressing their constitutional right to freedom of speech. (**Support**)

SB 663 – Sponsor: Mike Bernskoetter - Creates provisions for redistricting federal congressional seats according to the 2020 census **(Oppose – MRL Opposes any redrawing of a Congressional map that does not have a 7-1 drawing of districts. A 7-1 Congressional map would give Missouri and our Missouri Right to Life PAC the opportunity to work to elect a 7 Republican pro-life Congressional delegation. The Biden Administration, which includes Nancy Pelosi, has been to promote abortion on demand and have every American pay for all abortions. This has got to stop.)**

January 10, 2022 – Instead of just voting on the pro-abortion rule, Senate President Pro-Tem Dave Schatz offered an amendment to keep the threshold the same but increase the number of Senators needed, from 5 to 10 supporting Senators, to start the PQ process. With his amendment SR 436 passed the Senate by a vote of 21 YES to 11 NO and in so-doing the PQ process has been made more difficult to shut down the filibuster. 12 Republicans joined 10 pro-abortion Democrats to raise the numbers needed to begin the process to shut down the filibuster and come to a vote. The PQ process has not been changed for 51 years. This change will affect the ability to pass any conservative value issues like pro-life protections. This was not necessary for a super-majority Republican controlled Senate to do.
