At this time there have been 1,381 bills and 109 various resolutions filed in the Missouri House. And, there have been 723 bills and 79 various resolutions filed in the Missouri Senate.

NOTE ON HCS HJR 43:

As of March 2, 2023, HCS HJR 43 will not protect our Missouri Constitution and leaves Missouri wide-open for pro-abortion forces to deceive the public and put a right to abortion in our Constitution.

HCS HJR 43 needs to be amended in the Senate with stronger language supported by Missouri Right to Life in order to protect our pro-life laws and our Missouri Constitution from pro-abortion attacks.
