Legislative Update – April 7, 2023 Have a Blessed Easter!

There are 5 weeks left in the 2023 Legislative Session. The budget deadline is Friday, May 5th and the 2023 Legislative Session ends at 6:00 p.m. on Friday, May 12th.

This week in the Missouri State Legislature:

Missouri House of Representatives:

- 1. SS SCS SB's 45 & 90 was heard in the House General Laws Committee. SS SCS SB's 45 & 90 would extend insurance for a woman and her unborn child for up to 12 months after the birth of her baby. Watch our weekly Lifeline for further action.
- 2. SS SCS SB 133 was heard in the House Ways and Means Committee. SS SCS SB 133 would give a tax deduction for an unborn child. Watch our weekly Lifeline for further action.

Missouri State Senate:

- 1. The Missouri Senate has the state budget bills and will be having hearings and debate in the weeks to come.
- 2. Currently, in the House approach to the defunding of Planned Parenthood: The House has zeroed out public monies from going to any facility that performs or induces abortions. NOTE: Since abortion is banned in Missouri, organizations such as Planned Parenthood, which is the largest abortion provider in the United States, will continue to receive our tax dollars under this approach.
- 3. HCS HJR 43 regarding protecting our Missouri Constitution and ensuring that everyone across Missouri has a voice in how our MO Constitution can be changed is still on hold in the Senate waiting for a pro-life amendment.

NOTE ON HCS HJR 43:

As of April 11, 2023, HCS HJR 43 will not protect our Missouri Constitution and leaves Missouri wide-open for pro-abortion forces to deceive the public and put a right to abortion in our Constitution.

The pro-abortion forces have filed their initiative petitions to make abortion legal all nine months of pregnancy; and their language includes letting a baby born alive after surviving an abortion to be left to die, it is even more important now to amend HCS HJR 43.

HCS HJR 43 needs to be amended in the Senate with stronger language supported by Missouri Right to Life in order to protect our pro-life laws and our Missouri Constitution from pro-abortion attacks.

Information on the Initiative Petitions and why HCS HJR 43 MUST BE AMENDED TO PROTECT WOMEN AND UNBORN CHILDREN

The pro-abortion initiative petitions are dangerous to our Missouri way of life because:

- 1. The structure and support system for Missouri women would be seriously damaged if this initiative were passed. It would (a) allow for abortions to be performed up until the moment of birth, (b) allow anyone to perform an abortion with no licensing requirements, (c) deny any woman harmed by an abortionist her right to sue for malpractice to recover for her injuries, and (d) allow for the funding of abortions with public tax dollars.
- 2. Pregnancy Resource Centers could be forced to refer for abortion. Alternatives to abortion funding and tax credits for Pregnancy Resource Centers could be taken away.
- 3. These initiatives could Infringe on multiple constitutional rights such as:
 - (a) Clergy being prosecuted for not offering counseling for abortion;
 - (b) Praying on the sidewalk and counseling women on alternatives to abortion could be illegal.
- 4. Taking the life of a baby born alive after an abortion could be considered constitutional under this initiative. Physicians that choose not to give care to a baby born alive after an abortion, could not be prosecuted because it would be considered "reproductive choice" of the woman.
