# Legislative Update May 6, 2023

The House and Senate completed the budget by the constitutional deadline of May 5th. They also passed multiple bills. It was a bittersweet week for pro-life Missourians. Following are the Facts for the Week:

1. Conference Committees met and sent to the House and Senate the CCR HCS SCS SB's 45 & 90. This bill extends post-partum care to women in the MoHealthNet Program (Medicaid Insurance) for 12 months for the following situations based on the language of the bill for the "end of pregnancy": childbirth, stillborn, miscarriage and elective abortions.

This Conference Committee agreed to CCR HCS SCS SB's 45 & 90 taking the position of the House in stripping out the pro-life protections that would have prevented "end of pregnancy" from including elective abortions. In other words, care for women who choose elective abortions will be paid for with our public tax dollars for 12 months after her "the end of pregnancy", elective abortion.

We thank the Senators who voted against this compromise and refused to accept the compromise of supporting care after an elective abortion.

The House has not voted on the Conference Committee Report (CCR HCS SCS SB's 45 & 90). They have one week left in this year's legislative session and it is expected they will vote on this next week.

2. The Senate, prior to taking up the CCR HCS SCS SB's 45 & 90, took up proabortion Senator Lauren Arthur's bill, SB 106, dealing with health care and third read and finally passed it.

SB 106 includes the compromise language to have us pay for post-partum care for women for up to 12 months after her elective abortion.

This bill has been passed by both bodies (House and Senate) and is on its way to the Governor's desk.

We thank the House and Senators members who voted against this compromise and refused to accept the compromise of supporting care after an elective abortion. The "NO" votes are the pro-life votes from the floor:

Bottom line: Upon the Governor's signature of SB 106 as passed, and SB's 45 & 90, when passed, We will all be, required by law, to pay for up to 12 months of care for a woman who chooses an elective abortion.

3. BUDGET BILLS – Alternative to Abortion and Show-Me Healthy Babies Funding The House and Senate passed the following funding for these programs:

HB 10: Department of Mental Health and the Department of Health and Senior Services

A. If your legislator says they have banned monies for abortion, technically that is true. However, if you ask if they have banned public dollars from going to the nation's largest abortion provider, Planned Parenthood, that is not true.

Planned Parenthood Can Still Receive Funding because abortion is banned in Missouri. Read the language here:

Section 10.576. To the Department of Mental Health
