MISSOURI'S BATTLE TO KEEP MISSOURI PRO-LIFE

Pro-abortion initiative petitions seek to enshrine "right" to abortion in Missouri Constitution

In March, initiative petitions (IPs) were filed with the Missouri Secretary of State's Office (SOS) that seek to enshrine a "right" to abortion in our Missouri Constitution. The IP is the proces by which individuals can seek to put language on the ballot for voters to amend (change) our state's Constitution. To do so, they must file their petition with the SOS and then collect enough signatures in support of their petition that meet our state's statutory and Constitutional thresholds for such an effort. Presently, these petitions are in the courts. However, if they move forward, the next step is that pro-abortion forces will seek to gather signatures. If they get enough signatures throughout our state, their proabortion language to amend our Missouri Constitution will be on the November 2024 ballot for voters to decide. Should voters pass this into law, this language will cause a number of effects, as outlined below.

PRO-ABORTION EFFECTS OF "RIGHT TO REPRODUCTIVE FREEDOM INITIATIVE"

These consequences would appear to follow from the language used in the different versions of the Initiative, whether or not the drafters intended them. This summary does not purport to be an exhaustive list of the legal implications of the Initiatives.

1. Under all versions of the Intiative, the proposed amendment would--

- •allow anyone to perform abortions without a health care license. Abortions would not even require a nurse or midwife. (This would also apply to licensing for providing prenatal care, childbirth assistance, postpartum care, and birth control.)
- •forbid the state from requiring abortionists to offer mothers ultrasounds of their unborn babies.
- •forbid the state from disseminating to anyone seeking an abortion evidence-based information about the life and growth of the unborn child at each stage of development.
- forbid the state from particular informed consent requirements and from requiring a reflection period before an abortion.
- •forbid the state from enforcing health care regulations like those that apply to other health care providers.
- •forbid fathers of unborn children to have any right to advance notice of a proposed abortion or to have any legal standing to prevent it.

- •forbid the state from requiring health care professionals to take steps to save the life of a baby born alive after an abortion, because it would interfere with a chosen "pregnancy outcome" under the Initiative.
- •forbid the state from regulating surrogate arrangements that relegate women to the status of rented wombs.
- •allow abortions of babies of up to 24 weeks gestational age or up to "Fetal Viability" (as defined later in the Initative) for any reason or no reason.
- 2. Under some versions of the Initative, the proposed amendment would--
- •allow abortions to be performed until the moment of birth all 9 months.
- •allow for the funding of abortions with public tax dollars.
- •forbid the state from requiring the consent of, or notice to, parents of a pregnant minor about an abortion.

WHO issues new abortion handbook after arguing that killing the preborn 'saves lives'

The World Health Organization (WHO) has published a handbook for committing surgical and telemedicine abortions via the abortion pill regimen, while downplaying any impact on mental health.

In a press release, the WHO touted the handbook for "detail[ing] practically how health workers can apply human rights principles in their work to deliver abortion care." In reality, the WHO's "Clinical practice handbook for quality abortion care" outlines ways for physicians to systematically violate the preborn's human rights while endangering women's health.

The 66-page guidebook is intended to facilitate the application of the WHO's "Abortion care guideline," which insists on "[a]bortion care" being "timely, affordable, non-discriminatory and respectful." It contains information on surgical abortions, as well as dosage instructions for mifepristone and misoprostol, the two drugs typically used in the abortion pill regimen.

Telemedicine is included as a "recommended option as an alternative to in-person interactions with the health worker to deliver medical abortion services in whole or in part."

It adds: This means that the assessment of eligibility for medical abortion, counseling and/or instruction relating to the abortion process, instruction for and active facilitation of the administration of medicines, and follow-up post-abortion care can all be provided through telemedicine. Telemedicine services

should include referrals (based on the woman's location) for medicines (abortion and pain control medicines), any abortion care or post-abortion follow-up required (including for emergency care if needed), and for post-abortion contraceptive services, which may apply to both medical and surgical abortion.

WHO Head of the Comprehensive Abortion Care Unit, Dr. Bela Ganatra, touted medicinal abortions in a press release.

"Medical abortion has played a seminal role in expanding access to safe abortion globally, especially for women and girls in the most vulnerable situations who may lack access to health facilities or need to keep their abortion private by avoiding hospital stays, so it's important that healthcare practitioners can facilitate it as an option for abortion care," said Ganatra.

Pro-life doctors have repeatedly warned about the dangers of telemedicine abortions and the abortion pill more generally. After recent court decisions, blue states started stocking up on misoprostol and mifepristone as an insurance policy against nationwide prohibitions. The Food and Drug Administration (FDA) has liberalized access to the pill by eliminating the inperson dispensing requirement.

According to medical professionals, that in-person requirement is important for determining gestational age and ruling out ectopic pregnancies, among other things.

The WHO's handbook notes that "[n]either mifepristone nor misoprostol (nor both combined) will terminate an ectopic pregnancy." It also directs professionals to "[e]valuate the woman for an ongoing pregnancy as well as for ectopic pregnancy if she reports signs or symptoms of continuing pregnancy after medical abortion."

The true danger of the abortion pill is still unknown as the FDA has severely limited its reporting requirements, which it then used as a basis for loosening its regulations. Pro-life scholars have found purportedly troubling discrepancies in

the data. One study looked at Medicaid data and found chemical abortion-related ER visits increased at a faster rate than those related to surgical abortions.

Where better data has been found in Finland, researchers found bad news for abortion pill proponents. A 2009 study from the country showed that among 42,000 women, there was a *four times higher adverse event rate* for chemical abortions compared to surgical ones.

The WHO, however, is rabidly pro-abortion and argued earlier this year that abortion "saves lives." The months following Dobbs have indicated that the WHO is wrong in arguing that restrictions don't decrease the number of procedures.

Tweeting while you wait for your chemical abortion to be completed

Is it moral equivalency? Death and life? It's "better" than that. It's a shout-out to knowing what's "right" for you.

That it's fatal for the child can be ignored simply by holding the born child who "made the cut."

Sad. So very sad.

.... I'm going to go. Would you consider going with me?....

The woman was in the fifth decade of her life, when she picked up the phone and dialed the young mother's number. It was winter time. Roe v. Wade was just four years old. "There's going to be a program on pro-life in Mexico, Missouri on Tuesday evening. I'm going to go. Would you consider going with me?"

After consulting with her husband to make sure he was available to stay with the two-year-old and four-year-old girls, she agreed to go with the lady who had extended the invitation.

That night, besides the two of them, there were only three other people in the room when the Wilke Slide Show started. A cassette tape played the narrative while one of the others in the room advanced the slides in the Kodak carousel slide-projector. Dr Jack Wilke's voice led the viewer through a step-by-step description of the development of the unborn child through the twelfth week of pregnancy. Then came a slide showing a photo of the hand of an unborn child laying on the back of a dime for size reference. How did that picture come to be? The viewer soon found out as Dr. Wilke began to describe the types of abortion and what happens to the baby's body in each one.

The young woman was thunderstruck by the brutality of the procedures, tearing an unborn child limb from limb. She was also wowed by the logical arguments that Dr. Wilke posed to answer the pro-abortion arguments. When it came to the Rape/Incest argument, he said, "How can you justify imposing a sentence of Capital punishment on the innocent child and letting the perpetrator get off scott-free?"

The reasons for killing an unborn child often parallel the reasons advanced for Euthanasia, Dr. Wilke said. We allow the big to kill the tiny; the strong to kill the weak; the more perfect to kill the less perfect; the wanted to kill the unwanted. Remembering Roe: The Stories We Will Tell

On Saturday, June 24, pro-life groups across the nation gathered to commemorate the one-year anniversary of Roe's passing. MRL-Western Region was one of them. Below is the first in a three-part adaptation of the transcript of our Praise and Prayer Event.

In the years to come, we may look back on June 24, 2022 and tell many stories about the day we heard the words, "Roe v. Wade has been overturned."

- We will describe, of course, where we were and what we were doing when we heard the news.
- We may tell about the most pro-life President in American history and the power of the pro-life vote.
- We may talk about those members of the Supreme Court who stood for common sense, science, justice, and the sanctity of life.
- We may recount the dedication and the hours, which turned into years, of hard work by pro-life citizens who gave a voice to the voiceless and defended the powerless to bring this decision to fruition.
- Some may tell a story of good triumphing over evil, the righting of a wrong, a goal accomplished, or the dawning of a new era.
- But ultimately the story, and its glory, belong to God as the Creator and Sustainer of life and the orchestrator of these events. We give praise to the Lord who "works righteousness and justice for all who are oppressed" (Psalm 103:6). We thank God for establishing the work of our hands and bringing forth fruit from our labors.
- We may question why it took so long...as the Israelites did during their 40 years wandering in the desert, but who are we to question the sovereignty of God? In his wisdom, the time was now. And we praise him that we could be a small part of this monumental time in history.
- We grieve the millions of lives lost, yes, but know they are in his tender care.



• In the aftermath of Roe, we call on his strength to carry out the work that still needs to be done, not just to change laws, but the greater work of transforming hearts.

Pro-Life Victories since Roe Reversal

- As of the end of May, 14 states have full abortion bans, with 5 more full-abortion bans pending. Two states prohibit abortion after 6 weeks, with 2 more heartbeat-bans pending.
- Even with 24 states fully protecting abortion and experiencing a rise in their numbers, abortion overall in the United States has decreased at an average of about 5,000 per month since Roe's reversal (NY Times, 4/12/2023).
- Now that Dobbs and not Roe is our controlling precedent, we will have more victories in court because abortion proponents will be forced to defend abortion on its own merits.
- We have become a polarized culture, which at first glance would seem like a negative. However, it has become more difficult to be neutral, forcing us to take a stand. This is actually a positive for us because as the pro-aborts become more vocal and extreme, common sense and science prevail. The "right" to abortion has no constitutional or historical basis. But for 50 years, abortion advocates didn't have to justify that abortion was right; they simply hid behind the legality of abortion "rights." Since we are no longer under the blanket of legal access, abortion as a moral issue must be addressed. In the aftermath, we have seen the left shift their tactics to justify abortion as each of their argument's is debunked, while the truth of life in the womb remains consistent.

*Note: During this process, MISSOURI'S lawsuits can be filed by both sides. **INITIATIVE PETITION PROCESS*** MISSOURI After proposals are filed... The Secretary of State approves the petition form and drafts ballot title. The petitioner circulates petition. gathering signatures until May 5, 2024. The petitions are submitted to the Secretary of State by May 5, 2024 (6 months prior to the election). The petitions are distributed to local election authorities. Local election authorities verify the signatures. The Secretary of State issues a certificate of sufficiency or insufficiency by 5 pm, Aug. 6, 2024 (13 weeks before election). If there are a sufficient number of valid signatures, it is then placed on the ballot for

the November 5, 2024 general election.

- 3. The Initiative is so broadly worded that courts might interpret it to allow the following:
- Pregnancy Resource Centers might be forced to be licensed by the authorities and to refer for abortions.
- The Initiative could deny any woman harmed by an abortionist her right to sue for malpractice. (The immunity may also apply to negligent providers of prenatal care, childbirth assistance, postpartum care, and birth control.)
- Cloning for reproduction could become constitutionally protected. Even the weak restriction against it in the cloning amendment adopted in 2006 could be rendered a nullity.
- The Initiative could allow experimentation on unborn children with or without parental consent if performed as research to assist people in "exercizing their right to reproductive freedom."
